Mr G Beckett attended to ask about progress regarding the resiting of the bus shelter at Brookhouse - County are investigating possibilities.

12/131 MINUTES OF THE PREVIOUS MEETING HELD ON 14th February 2012

The minutes of the previous meeting held on 14th February 2012 were confirmed and signed as a correct record.

12/132 POLICE AND COMMUNITY TOGETHER (PACT).

Pc Carl Wood reported that he was back on 'light duties' following his recent operation: unfortunately Carl will require a second operation and is unlikely to be back fully fit for some time.

Carl is working on the planning of the Policing of the Appleby Horse Fair. This will work in a similar way to last year with Police managing and visiting sites twice a day. Cumbria will be enforcing Roadside Orders until 28th May when the Authorised sites will open.

Crimes reported include nuisance at Caton Community Primary School and on Brookhouse Road. Wing mirrors on two cars had been damaged. An incidence of bullying is being investigated as is a problem with a bag at the Station Hotel. There was a shoplifting incident in the Co-op (whisky taken) and an arrest was made in Skipton.

Car parking on the road at the Crook O'Lune will be monitored and seems to be worse since the introduction of car parking charges.

A report of a tent in the grounds of Moor Platt will be investigated.

The SpID's will need to be recharged somewhere after the Caton Police Station closes. The possibility of housing them in the Victoria Institute or elsewhere will be investigated. CSPO Peter Woods will still be looking after them.

Bus shelter cleaning continuation of City Council contract £ 18.50/month (same as last year). City will be asked to wash down the shelter at Copy Lane.

The property check has highlighted the following:- White line in the car parks and potholes in Station Road. Pointing at the Fish Stones and a gate problem at Fell View. A planter on Sycamore Road has been demolished and there is a pothole on Artlebeck Road.

It was agreed to write to County regarding the knock on effect of parking charges at the Crook O'Lune and dog walkers parking in the village car parks. A note in the Link reminding residents that parking at Bull Beck is still free of charge.

Residents are encouraged to report dog fouling problems.

A letter of thanks to the Litter Pickers would be sent.

Geoff attended the tree care event and found it informative. Grass at the base of the trees will be 'mulched'.

Confirmation from County will be required otherwise the Doctors may pursue purchase of the complete site with a 'lease back' arrangement for the car park.

12/140 MOOR PLATT

The current position is that the County Council has accepted an offer on Moor Platt from a Care Home Operator and we understand it is their intention to keep the facade and start work as soon as possible after completion. Contracts are being exchanged and a completion date has been set for 10th April. No details of the proposed purchasers are available.

The Parish Council would like to seek an early meeting with the purchasers to see their plans for the site.

The exhibition on Moor Platt's past will be held on Saturday 17th March.
