## What is a Neighbourhood Plan?

- Introduced by Localism Act 2011
- Statutory weight
- Community-led
- Wishes on for instance: Housing/Employment/Leisure/Retail/Transport
- Shaping not stopping development
- Must conform to the National Planning Policy Framework (NPPF) and Lancaster and Lancashire local plans

## What steps are involved?

- Designation
- Prepare NP
- Consult
- Submit to Lancaster City Council (LCC)
- LCC checks and consults
- Formal independent examination
- Referendum in the village
- If agreed LCC "makes the plan"

#### Where are we now?

- Caton-with-Littledale Parish Council has been "designated" to lead on the NP for our area
- Visit from a consultant from Locality in March/April to advise on the NP process
- Several councillors visited the NP display in Wray in July or attended their committee meeting
- Now need to decide whether to commit to doing the NP

#### Costs

- £2000 allocated for NP in PC budget for 15/16
- Grants available to help pay for consultants, printing, materials, room hire etc
- Most of the work done by volunteers —
  management of the project/ surveys/ focus groups/
  photos/ interviews / drawing maps/ keeping
  accounts/ coming along to meetings with ideas and
  encouragement!
- Consultant for professional and technical support

## Advantages and disadvantages

Statutory force

Focus on what people who live or work in the village want to see happen

Community engagement

Training and skills development for volunteers

Need a clear vision

Has to be consistent with local and national plans

Does not stop development

Huge investment of time, energy and resources

Can take years
